It is also requested that All Academic Departments/Centres and Affiliated Colleges under the University of Calcutta may send us proposals/names of journals which they would like to be included in the UGC Approved List of Journals for consideration of the Academic Journal Expert Committee of University of Calcutta strictly using the prescribed format attached with this notice. Incomplete forms and proposals will not be considered for this purpose. Please send required proposal to the undersigned by email by filling the attached form within 05.05.2017.

A compliance report will also be submitted to the Department of Higher Education, Govt. of West Bengal by the University subsequently.
