Eligibility: Any candidate who has passed the M.A./M.Sc./M.Com./MLIS or equivalent examination of the university with 55% marks in aggregate [SC/ST/PWD (minimum 40% disability)/OBC (non-creamy layer) with 50% marks] students in the respective subject / subjects. Students who are taking M.A./M.Sc./M.Com./MLIS or equivalent Part – II Examination or Final Semester Examination in the above mentioned subjects may also apply provisionally and sit for the Admission Test, but their final admission would depend on passing the examination obtaining the required marks mentioned above. Candidates who have qualified NET and or SET or any equivalent National level Examination are exempted from the written test, but not from the interview/ vivavoce. Candidates of any stream of M.A./M.Sc./M.Com./MLIS and other PG degrees from recognized universities are eligible to apply for the above mention subjects.

Candidates holding the qualifying degree from universities/institutions of other States and or candidates holding the qualifying degree from "Distance course and or Open university from any States" are required to submit the "Equivalence Certificate" from the University of Calcutta (obtainable from the Office of the Registrar, CU) at the time of submission of application form.

Candidates of Reserved category of other States are required to submit the "Domicile Certificate" (at least for the period of 10 years) from the competent authority from Central Government or State Government having local jurisdiction over the place of permanent residence of the concerned candidate or his/her parents, as

the case may be, viz., (i) District Magistrate, (ii) Additional district Magistrate, (iii) Deputy Magistrate (iv)Deputy collector,(v) Sub-divisional Officer, (vi) Block Development Officer, (vii) Superintendent of Police, (viii) Additional Superintendent of Police, (ix) Sub-divisional Police Officer or Deputy Superintendent of Police,(x) Commissioner, Additional Commissioner, Joint commissioner, Assistant Commissioner of Police Commissionerate, (xi) Judicial Magistrate of any rank or position in the concerned District or Metropolitan locality or Hon'ble Court at Calcutta or Hon'ble Supreme Court of India, (xii) Commissioner, Additional Commissioner, Joint Commissioner of Municipal Corporation, (xiii) Executive

Officer of Municipality, (xiv) Assistant Secretary/Equivalent or above in the Secretariat to the Government of West Bengal (including GTA) or Central Government, (xv) Deputy Director of above in the Directorate to the Government of West Bengal or Central Government.

Every Official certifying the domicile status of the candidate or his/ her parent must provide one's Full NAME, DESIGNATION, PLACE OF POSTING WITH ADDRESS, LAND LINE AND MOBILE NUMBER ALONG WITH EMPLOYEE IDENTITY CARD NUMBER. MANDATORY CERTIFICATION from ANY AUTHOROTY OTHER THAN WHAT HAVE BEEN ENUMERATED ABOVE WILL NOT BE ACCEPTED.

Form: The prescribed Application Form for admission to M.Phil course for the session 2020 (January) – 2021(December) can be downloaded from the official website of University of Calcutta (www.calunive.ac.in) Downloaded application forms completed in all respect with the proof of payment of Rs.500/- for General and Rs.250/- for SC/ST/PWD category. The fees can be paid through SBI Online.

Reservation: For SC, ST, OBC- A, OBC-B and PWD candidate will be made as per University/ Govt. rules. Reservation of 3% of seats for PWD within each respective category (SC/ST, OBC-A, OBC-B/ unreserved of the concerned subject).

100 point Roster of West Bengal Board of Higher Educational Institution, wherever applicable, will be followed in final selection.

Submission of Forms: Completed Application Forms of Education, Sociology, History, Political Science, A.I.H.C., will be received by the office of the Secretary at Alipore Campus. Form for Library & Information Science will be received at office of the Library & Information Science, Asutosh Building (3rd Floor) College Street Campus. For rest of the subjects, forms will be received at the Secretary's Office (Ground Floor) Asutosh Building, College Street Campus, between 12 noon to 4.00 P.M. on all working days from December 09 –19, 2019, (i.e.,the last date of submission of filled in forms is 19th December 2019)with all relevant self attested documents. However, original documents are to be shown at the time of submission of application form.

Course Fees: Rs.4000/-are to be paid by the selected candidates at the time of admission.
