Advertisement for Admission to Ph.D Programme

RET in Business Management 2022

Applications are invited for admission to the Department of Business Management, University of Calcutta for PhD Course and subsequent research work leading to PhD degree in Business Management.

The admission to the Ph.D programme is guided by the '**Regulation for the Degree of Doctor of Philosophy, Ph.D Regulation 2016**' of Calcutta University and other relevant rules and orders of the University. Reservation rules as applicable as under National /State reservation policy.

Candidates desiring to pursue research work in Business Management may apply in the prescribed pro-forma by paying Rs 100/ through SBI collect (Calcutta University > Payment for MISC Fees > Application for Admission to PhD) by June 3, 2022. Scanned copy of the application, along with the self –attested relevant documents and the payment receipt, is to be submitted through email to subhankardutta092@gmail.com with CC to dr.suvasis123@rediffmail.com

Or physically visiting the Alipore Campus (I, Reformatory Street, Kolkata 700 027, 6th Floor) and depositing it at office of the Head to Mr. Subhankar Dutta on working days between 11A.M. to 3. P.M.

A. The Process of Admission:

1 Written test will be of 100 marks of 3 (Three) hours duration. The modules of test will be 3(three) namely the following:

- i)'Quantitative and Logical Reasoning ' with weight of 40%.
- ii)' Analysis of a Business Issue' with weight of 30%.
- iii) Two concept papers' (to be selected from the given research themes) with weight of 30%.

Qualifying marks for written test is 50.

Interview of 100 marks following the clauses of 5.4, 5.5, 5.6, 5.7 and 5.8 and other clauses as applicable.

Candidates for admission to the Ph.D. programme shall have a Master's degree in Business Management candidates and also as permitted by clause 3.1 and clause 5.1 of '**Regulation for the Degree of Doctor of Philosophy, Ph.D Regulation 2016**' of Calcutta University

B. Eligibility:

1. Candidates must have completed their **Master's Degree or equivalent** in Business Management/ Human Resources Management/ Commerce/ Social Sciences/ Humanities (excluding Music, Visual Arts, Fine Arts & Dramatics)/ Sciences/ Law/ Library Science/ Technology/ Medicine or allied disciplines, and as applicable subject to approval of Ph. D. Advisory Committee before registration.

a) from University of Calcutta or

b) from other UGC recognized Universities/ Institutes, with **equivalence clearance** from relevant University body as and where applicable.

c) Candidates working in public sector/government departments/ government companies and /or private firms/companies or Non Profit institutions must apply through proper channel or submit NOC from their present employer with the application form.

2. Candidates who are exempted from Written Test under the 'Regulation for the Degree of Doctor of Philosophy, Ph.D. Regulation 2016' of Calcutta University may apply for appearing for Interview, subject to equivalence clearance from relevant University body as and where applicable (Clauses 5.1 A and 5.1 B are to be adhered as and where applicable).

C. Application Process:

All candidates (including those in exempted category) are required to **Down Load the Application Form** from the University Web Site: www.caluniv.ac.in (Admission Notification) or Departmental Website: www.bmcaluniv.org and submit the same to the office of the Head on or after 25. 05.2022 * and on or before 03.06.2022 * between 11A.M. and 3P.M. on all working days along with Equivalence Clearance from relevant University body, University of Calcutta and relevant other documents . Physically the form can be submitted to the department or by email to subhankardutta092@gmail.com with CC to dr.suvasis123@rediffmail.com along with scanned copy of payment of Rs 100/ through SBI collect.

- 6) The interview will be held offline.
- 7) **Date of interview: July 3, 2022 *.**
- 8) **Numbers of seats: 20** at present will be enrolled, if qualified, as Probationary PhD Students under the empanelled supervisors, **Relevant Nationals / State Reservation policy shall be strictly followed.**
