- 1. Eligible Tenders/QUOTATIONER will have to download the tender papers from the website & drop the filled tender papers signed with seal and date at every page along with copy of Valid Trade license's, GST & PAN and Credential for satisfactory completion of similar nature of job amounting to at least seventy five percent of the job value in a single tender from any Government, Govt. undertaking or University of Calcutta in the last three financial yearin sealed envelope in the Tender box kept in the Office of the undersigned with in the specified time mentioned in the NIT./NIQ which will be opened by the undersigned or by his representative with in the specified time and date mentioned in the NIT/N.I.Q. - 1. - **6. Earnest Money Deposit**: Depending on the type of goods to be purchased or work to be done, Earnest Money Deposit (EMD), also known as Bid Security, must be obtained from the bidders-except those who are registered with National Small Industries Corporation (NSIC) or MSME to safeguard against a bidder withdrawing/altering his bid during the bid validity period. The bidders are required to furnish Earnest Money Deposit (EMD) along with their bids. Amount of Earnest Money Deposit (EMD) should be five per cent of the estimated value of the goods to be purchased or work to be done.
